As Clerk of this meeting, I publicly announce that in compliance with the provisions of the "Open Public Meetings Act" adequate notice of this meeting of the Jackson Township Council has been advertised in the manner prescribed by law.

COUNCILMAN KAFTON – The tragedy of the Nicholson Family is devastating. I have 3 boys; one has a license and the other 2 have permits and I immediately called all 3 of them to make sure none of them were on the road at that time because when we found out there was no information yet. It appears we recently had a lot of tragedies. The other night a bicyclist was struck and killed and someone hit a tree last night and was killed. Our roads are open country roads and lot the younger kids don't realize how slippery the roads can be with leaves in the rain. We had created a Safe Roads Committee and at this point together with the high school and we need to make them more aware. As elected officials, it is our job to inform people of safety. We need a seminar in both high schools to educate before they get on the roads. I cannot imagine what is happening to the Nicholson family. He was appreciative to the schools outside of Jackson that honored them. I have lived in Jackson all my life and I cannot remember a year where our high schools were not hit with a tragedy. Jackson is the 3rd largest town in the State as far as square miles. I am asking this Council to get together with the School Board. We know we have a fine Police force and great teachers, but we have to take many steps to inform these children before they get out there.

COUNCILMAN MARTIN - Absent

COUNCIL WOMAN RIVERE – As a mother and grandmother I cannot image what this family is going through. I too was going to ask the Safe Roads Committee to get together. Unfortunately, the President and Vice President both stepped down earlier this year and that Committee is dormant. I was one of the liaisons to the Committee and I would like to send out an appeal to the public to reconvene this Committee. Council President Bressi feels the existing people can work on this. Councilwoman Rivere expressed when they stepped down, we attempted to have one of the other members take over but they were unable. Council President Bressi suggested he and Councilwoman Rivere contact the remaining members and work alongside with the Schools. Councilwoman Rivere wished all the residents running for Council good luck.

COUNCIL VICE PRESIDENT UPDEGRAVE – I believe into reconvening the Safe Roads Committee as we have had one tragedy after another in Jackson. We need to look into educating our children better. I would like to recognize and thank our Wounded Warriors who got together once again and thank them for their services and sacrifices. We had a good time and it was a good turn out.

COUNCIL PRESIDENT BRESSI – When you hear about this kind of tragedy, you look at your children differently. I too remember when my kids were early drivers and being nervous and sitting by the phone. Unfortunately, I did receive a phone call as one of my children was run down as a pedestrian. I will join Councilwoman Rivere to educate our children. He thanked everyone who came out for the Wounded Warriors; it was well attended and it was a very nice day.

DISCUSSION AGENDA:

1. COUNCIL PRESIDENT BRESSI -

A. Amend Administrative Code – Re-Organization Meeting Date – Asked to start working on the Administrative Code and change it in line with the November Election and all the re-organization dates being January and not July. He asked it be ready for the November 20, 2012 meeting. Attorney Cipriani agreed it's a good idea and she would take a look at it to see if it can be done simply by Ordinance or by a search in the Code.

2. ADMINISTRATOR TORRES –

A. NJDEP close off portion of High Bridge and Success Road – Carried to 11/20/12.

3. TOWNSHIP CLERK EDEN -

A. Township Clerk Eden announced the next Township Council Meeting is scheduled for November 20, 2012.

PUBLIC COMMENT, ANY TOPIC

RAY CATTONAR - 11 FORDHAM ROAD – Questioned why did Joe Fiero, Chairman of the EDC, inappropriately promote 2 candidates on the EDC member website and wrote untrue statements attacking him? He assumed that website is a government owned website by the Township and that is considered illegal. He also found out that Mr. Fiero had OPRA requested my email correspondence with Pat Wood regarding Jackson Day. He stated the integrity of the EDC seems to be compromised and he wanted to know why the Chairman is still in power. Council President Bressi stated he himself is on the EDC and he did review it. He would applaud Mr. Fiero on the general subject content about the EDC, however, the wording about the specific candidates was inappropriate. Council President Bressi asked Attorney Cipriani to look into it.

Attorney Cipriani stated both Council President Bressi and Mayor Reina had contacted her today about the issue that he had raised. She stated that is not appropriate and correspondence from her office will be forthcoming explaining and directing that use of a Township position for political statements is not appropriate. Mr. Cattonar stated those comments were totally false and inaccurate; his involvements were as a sub-committee member for Jackson Day. Attorney Cipriani stated as far as the Township's perspective, the subject matter using a Township position to disburse political ideas and comments on current elections is not appropriate. Mr. Cattonar asked who owns the email site that links all the members? Attorney Cipriani stated she didn't know, any forum that is made available through a creation of a Township entity should not be used for these purposes. The parameters of what can and cannot be done are not always clear to people; it is the Township's position to make that clear. Mr. Cattonar felt the EDC's integrity has been compromised and he effectively announced his resignation tonight.

Councilman Kafton stated a resident who volunteered, to what I consider to be one of the most important boards, has stepped down because another member of this committee has chosen to use this government to politic. I believe Mr. Cattonar should not step down . I won't ask Mr. Fiero to step down but I believe Mr. Fiero should voluntarily step down. Mr. Fiero's job on that board is to go after commercial ratables. He clearly doesn't understand the job. If he doesn't step down, I am asking the Council to make a statement to all volunteers that we do not tolerate politicking on these boards.

Council President Bressi clarified that the Mayor appointed him and suggested sending a letter to the Mayor. Council President Bressi stated that Attorney Cipriani is sending over correspondence to Mr. Fiero stating his inappropriate comments. Councilman Kafton stated since this Council created that committee we should make a stronger stance than that. He understands how politics work and we are here to serve the town. Attorney Cipriani stated no doubt it should have not been made at that forum. It is my experience that with appointed positions, particularly the level of education and what's appropriate and what's not appropriate that's given to elected officials, is not often given to appointed officials and maybe we can strengthen that. It is not uncommon for there to be some misperception of what the parameters are.

Councilwoman Rivere felt the flyer was both pro and con. It was pro certain candidates and against others. Attorney Cipriani stated it is her recollection there were favorable and unfavorable statements. Councilwoman Rivere stated it was the EDC, it was more than inappropriate it was using an office of a committee. Councilman Kafton feels trashing another member on the board does not encourages volunteerism. If Mr. Fiero does not want to do the right thing, than we should send a strong letter to the Mayor requesting him to be removed. Councilman Kafton asked for Council's opinion. Councilwoman Rivere agrees a letter to the Mayor is appropriate here. Council President Bressi stated the seat is up January 1, 2013. Council President Bressi feels the Mayor is well aware of it. The appointment is up in January and Mr. Fiero has the right to remain or voluntarily resign.

PAUL MAYEROWITZ – 91 CYPRESS POINT LANE – He felt that to characterize it, as a government website, is inaccurate. He read the email as a member of the EDC and feels Mr. Fiero laid out an email of the different perspectives of the individuals that were running for Council on economic development. He was going to utilize those differences to foster a meeting to review those issues to try to decide were the EDC should be going. He summarized the pros and cons and underlying issues. He favored one approach vs. another, and he believes you are allowed to disagree as members of the committee. He stated Mr. Fiero pointed out that members of the committee could agree with either candidate's position. These are functions that a chairman of the committee is supposed to be doing.

Councilwoman Rivere asked if all the EDC members' opinions were placed in this email? Mr. Mayerowitz answered no, these are the thoughts of the chairman. One of the elements that this Council has never wrestled with is volunteerism on committees. We choose people to serve on committees because we expect them to fulfill the responsibilities of that volunteer position. Councilwoman Rivere stated the question that was raised was whether a political statement belongs in the forum of the EDC; not what you do behind closed doors. It was an email supporting 2 political candidates and saying no to 2 others. Your attorney said no and I disagree. The Council President and Councilman Kafton said it was

inappropriate. Mr. Mayerowitz felt Councilwoman Rivere is confusing 2 issues. Council President Bressi called for a recess.

8:10 p.m. - 5 MINUTE RECESS

8:20 p.m. – MEETING RESUMED

Councilman Kafton feels Mr. Mayerowitz lost focus and is diverting the issue. Politicking on this board had been going on and the chairman has lost the focus. Councilman Kafton felt he should be removed.

JOE FIERO – **25 DANIELLE COURT** – One of he jobs of a chairman is to maintain the moral of the committee. As was made clear tonight, we have a lot of meetings where people don't show up and disband. A couple of weeks ago, a Q&A had been published in a local handout about business in Jackson, which addressed the issue of attracting new business in town. That immediately got my attention and many members of my committee because of what was said and not who said it.

Several committee members brought Mr. Cattonar's comments to my attention. Attorney Cipriani asked him if he was making remarks on political matters. She asked him to clarify making those comments as an individual and not the EDC Chairman. Councilman Kafton asked Mr. Fiero where he read those comments? He explained it was the J-Town Magazine. Councilman Kafton stated if he had a problem with it, why didn't he put in a letter to the Editor of J-Town Magazine and not use his authority as the EDC Chairman? Mr. Fiero explained he felt it appropriate to explain to the other members why Mr. Cattonar would belittle the work of the EDC.

Councilman Kafton feels it is politics. And as Chairman of the EDC, he feels he should not be politicking on that board. Mr. Fiero feels Councilman Kafton's opinion is incorrect. Council President Bressi agreed with Mr. Fiero & Mr. Mayerowitz that the subject matter was appropriate by the EDC but some comments were inappropriate from the Chairman. The website is not owned by Township but it was the EDC tool used for total communication, therefore, it is tied to the Township.

Attorney Cipriani will be forwarding her legal opinion of the document over to the Council. Her concern is with this meeting and political campaigning cannot occur at Township meetings. Council President Bressi felt this topic should be brought to a halt, since its been governed by the Township Attorney as inappropriate. Attorney Cipriani stated it is the public portion of the meeting but I may still have to caution if he is speaking as the Chairman of the EDC. Council President Bressi asked him to define if he is speaking as an individual or as a chairman. Mr. Fiero stated he is now speaking as the chairman and he read an internal memo sent by the chair of the committee to the members of that committee. This is a committee housekeeping issue. We have a member who has attended only 2 meetings in one year but has chosen to use the fact that he serves on the committee as part of his candidate bio. He has often made disparaging comments with respect to the committee and the works of its members. As chair of the committee, I feel it is important that those serving feel appreciated in serving. Over the past year, Mr. Cattonar has done anything but. This note was to inform the members of the upcoming meeting and to advise committee members that they did not need to suffer quietly as Mr. Cattonar spoke ill of them. At no time did I make any statement recommending a vote for or against any candidate running for Council. In fact, I ended with the words, "If you agree with Ray's direction that it is your right. If you don't, you are free to speak out against his platform. As a committee member, you are free to clarify the works and directions we have chosen as a group. Lastly, let's look at the distribution list of this memo. In total there are 14 people that share the correspondence on this list. Out of the 14, 10 are residents, which include me. Of the remaining 9, 7 are either candidates involved in the campaign or have openly expressed their affiliation at a prior time. In total, there are 2 residents on the committee that received this memo with no affiliation. That is far from politicking. As chair of the EDC, I have the right and the responsibility to communicate with my members in matters concerning the committee itself and issues that would effect or influence the economic development of our town.

He began to speak only as an individual and not a member of the EDC. Mr. Cattonar had previously asked why I OPRA'd certain information. He asked Attorney Cipriani if it has been OPRA'd, could it be shared? Attorney Cipriani answered yes. He read an email dated 8/22/12, referencing signs for Jackson Day from Warren Siegel to Ray Cattonar & Bonnie Barrington – Thank you for mentioning that you will use Sign-a-Rama of Toms River for your lawn signs when running.

RAY CATTONAR –11 FORDHAM ROAD - I have never made any disparaging comment against the EDC. My work with Coca-Cola was again as a sub-committee member. My correspondence was directly with the Mayor. He then connected me with Mr. Torres, who neglected to contact Coca-Cola and it had nothing to do with the EDC.

BONNIE BARRINGTON – 930 HYSON ROAD – Felt Mr. Mayerowitz and Mr. Fiero are confused as why the committees that we have that serve the Township seem to have a hard time holding members. From tonight's behavior I can see why someone wouldn't want to serve on a committee. The behavior is despicable and he made a fool out of himself. There are young people here trying to learn about government and it's a waste of their time. I have been a victim of Mr. Mayerowitz & Mr. Fiero's antics. I still have my photo posted on a website. Despite my pleas to take it off, it still remains. He has bashed me during the CBAC audit and that is something Mr. Fiero takes pride in. Mr. Mayerowitz audited my personal business and my business records with the Board of Ed. He overstepped his bounds as a chairperson of a committee.

I am asking these 2 gentlemen to step down from their respective committees. Neither one of them represent what we are looking for. Mr. Mayerowitz recently OPRA'd her resignation letter and also my emails between the Township Officials and me with the claims of misappropriated funds. He should have put this much effort into the audit of the Recreation Department so maybe it could have been productive. I myself was part of that article that came out in J-Town Magazine referencing the commercial ratables. We both collaborated on the response to that question and there was the issue of Coca-Cola reaching out to us about sponsorships. As a chairperson looking to bring in ratables into this town, he has failed miserably.

RYAN ARCHER – 486 FRANK APPLEGATE ROAD – He had concerns of the illegal dumping and the recent Court Order with a deadline for November 26th for the remediation of the garbage at the Frank Applegate landfill site. I applaud the Township for getting involved, especially Mr. Kelly. He asked who from the Township would be responsible for overseeing the remediation of the landfill? Attorney Cipriani stated it is the DEP's responsibility and Council President Bressi stated that Code Enforcement would follow through. Attorney Cipriani stated the DEP is to notify us when the actions will begin but sometimes they do not. So if you notice that a DEP Representative is not present, then call the Township and we will make sure Code Enforcement will come out there. Mr. Archer stated they would be going to the Zoning Board as the approval for application of construction of the site is prior to the November 26th clean up. The Environmental Commission is sending a letter to the Zoning Board in their belief that it shouldn't be reviewed. Council President Bressi stated the Environmental Commission is not a statutory board, they cannot say to approve or stop an application.

HEATHER ZIEGLER – 5 SUSIE LANE (STUDENT – JACKSON MEMORIAL HIGH SCHOOL) - Questioned if students can be volunteers for the Safe Roads Committee. Council President Bressi stated yes as we previously had students on that committee. Councilwoman Rivere stated yes students are welcome but unfortunately it's disbanded and we're hoping to get it back. Council President Bressi instructed Ms. Ziegler to submit her name. Ms. Ziegler stated she knows, by being a student and sitting in an assembly, it is similar to other things out there like Project Crash and the parents and Police that come in to talk to us. She suggested the students and parents attend more assemblies as a requirement; this way the parents are with the students. Council President Bressi agreed but stated the key about the committee is to identify areas that are more prone to accidents and areas that need improvement. It is a combination of both and Councilwoman Rivere and I would actively be working as members as we will be working with the schools. Township Clerk Eden recommended Ms. Ziegler send something in writing to her attention

and she will forward copies to the Council and the Mayor. Council members thanked Ms.

Ziegler for her efforts and Councilman Kafton feels she would be perfect for this board. Ms. Ziegler had worries about volunteerism, as to what transpired tonight, and the Council had assured her not to compare what transpired here tonight to future meetings.

PAUL MAYEROWITZ - 91 CYPRESS POINT LANE - He asked Attorney Cipriani regarding the conversations and emails of the CBAC for review of budget details, which are all of a consultative nature, if they are confidential or may they be released officially? Attorney Cipriani stated those materials are not releasable until the conclusion of the budget process or until the budget is presented and adopted. Whether that privilege will remain would depend on the specifics of the document. Mr. Mayerowitz asked if that means that members of the committee can release those documents without approval? Attorney Cipriani stated if the documents that your referring to are deliberations of different ways to approach the budget problems and the purpose of those individual communications is for incorporation into a report to be given to the Administration and/or the Council for approval and review of those documents, than those documents should not be released until that process is complete or they are infact released by the entity that are targeted to in terms of the actual governmental entity, not the advisory committee. Mr. Mayerowitz asked what the action would be for the same circumstance and review of the EDC's email with the document and whether or not it's released to the public, whether or not its transmission to the Editor of the J-Town Magazine was appropriate or inappropriate?

It's my right to OPRA certain documents and I've done so with the knowledge that the Township Clerk has to respond to it. Elected officials are complaining of OPRA requests. Ray Cattonar has submitted OPRA requests and no one complains. Why are elected officials worried about transparency? What are you afraid of?

He read from the letter (an OPRA request) from Warren Seagal, Sign-A-Rama, Toms River - Hi Ray and Bonnie, attached is a proof of a 4-6' banner (quantity 2) that we would donate to your Jackson Day. Let me know your thoughts and when you need it by. My understanding is that Ray is part of the Jackson Day committee, he solicited a banner from Sign-A-Rama and Sign-A-Rama donated it, which is troubling to me that you would use Sign-A-Rama from Toms River for your lawn signs when you're running in Jackson. I look forward to working with you both on your campaign. Mr. Mayerowitz feels that is a troubling email.

BONNIE BARRINGTON – 930 HYSON ROAD – I told the owner we needed a quote. I didn't tell him he had the business; he ultimately won the job. We paid for the signs out of our campaign money. We solicited for free signs and free banners for Jackson Day. One had nothing to do with the other. This whole atmosphere that these men portray is an image and whether or not you meant it to come across the wrong way; the point is that it is. You're unprofessional and you're serving on committees and Paul Mayerowitz should have been asked to step down. As a woman, I resent the fact that he has attacked me on several occasions and this Council, for the most part, has not asked him to step down. Thankfully he is moving and hopefully this will be his last meeting. I would address it to Mayor Reina but he has not been here for about 9 months. I do feel you need to set some guidelines as to what the responsibilities are for these committee chairmen. This way its clear when someone steps outside those bounds, as it is clear these two men have done that.

RAY CATTONAR - 11 FORDHAM ROAD – Coca-Cola has once again called and they are very interested to sit down with the Township to discuss a deal. They have acknowledged that no one has returned their call. Attorney Cipriani asked him in what capacity are they calling you, as you are not a representative of Jackson Township? He stated he was a subcommittee member at the time of Jackson Day when he had called them and asked them of their interest in sponsoring the event. He referred the information to the Administration, which he did again today. Perhaps instead about fighting over it someone can return the call. Township Clerk Eden stated if Coca-Cola is involved in the Township, than it is a public bid. Mr. Cattonar compared other towns that did not go out to bid. Township Clerk Eden reiterated it is a public bid. Council President Bressi stated Mr. Torres is out of town and we will take care of that.

RYAN ARCHER – 486 FRANK APPLEGATE ROAD – Is disturbed the Safe Roads Committee is put on the shelf. Council President Bressi stated there were resignations and we are trying to put it back together. Mr. Archer will be leaving his contact information with Township Clerk Eden. Councilwoman Rivere stated we will definitely be seeking new applicants for the committee. Township Clerk Eden informed him that there is a form on the Township website called Citizen Leadership Form/application which can be downloaded, completed and forwarded back to the Township Clerk's Office and we will forward same onto Council.

JOHN BURROWS - 322 MACKENZIE DRIVE - I was a member of the Safe Roads Committee and we had investigated a lot of things. We had a lot of great help and came back to the same conclusion that it is driver training and education. There are over 5 Million accidents a year in this country resulting in 32,000 deaths. Unfortunately, Jackson tracks fine. We're on target and we are right where we should be. It is very sad but there is nothing wrong with the roads in Jackson. Every road we did identify, we found out that the County was right on top of it and there was a plan to rebuild or restrain. Council President Bressi stated the roads we identified with the Police Department, we did move forward and we need to start looking at common areas. Mr. Burrows stated that one of the key people was Sgt. Geoghegan. We need him back on board and I would love to come back myself. Councilman Kafton stated we saved a lot of money tonight on some change orders, which will go back into the Capital Funds. Mr. Burrows feels it would be good to get those funds back because nationwide the No.1 killer of teenagers is motor vehicle accidents. I would push it on education and training and although we have a state mandated driver education in our high schools, I don't think it's good enough. Why can't Jackson have a better young driver training education program? I think that is where we would have our best spending of money. Councilwoman Rivere stated a member of the Board of Ed was on our committee. Unfortunately when the leadership could no longer handle the leadership, no one else stepped forward. The committee is officially still in existence with its membership, which will be reappointed in January, but that committee was never disbanded. We haven't met because no one had stepped forward to take leadership. Mr. Burrows stated at their last meeting, the Chairman was very excited about a driving simulator program, which he believes would be beneficial. Councilman Kafton agrees it is awareness and education. He offered the suggestion in the upcoming budget, perhaps some funds be allocated toward this. Council President Bressi expressed that the Department Heads have started putting their budgets together and it will be looked at.

PAUL MAYEROWITZ – 91 CYPRESS POINT LANE – The Board of Ed has not signed a contract with Coca-Cola. They are having discussions with Coca-Cola to possibly have their water-flavored products in their vending machines and the expected revenue from this deal, if consummated, would be \$2000 annually.
