AUTHORIZING CHANGE ORDER NO. 1 FOR THE TOWNSHIP'S 2021 NJDOT
MUNICIPAL AID ROADWAY IMPROVEMENT PROGRAM FOR SUSAN DRIVE**

WHEREAS, the Township of Jackson has previously entered into a contract for certain roadway improvements to Susan Drive in accordance with the FY2021 NJDOT Municipal Aid Grant Program; and

WHEREAS, on April 6, 2023, the Township Engineer, Stephen, Schreiber, P.E., has recommended a Change Order for this Project in the amount of 3.55% of the overall contract for a total of \$19,208.40 as set forth in the attached proposed Change Order No. 1; and

WHEREAS, the Township Council wishes to accept the recommendation of its consulting engineer to authorize said Change Order;

NOW, THEREFORE, BE IT RESOLVED, this _____ day of _____, 2023, by the Township Council of the Township of Jackson, County of Ocean, State of New Jersey, as follows:

1. The Township of Jackson hereby authorizes Change Order No. 1 for its Contract with Earle Asphalt Company for the FY2021 NJDOT Municipal Aid – Roadway Improvements to Susan Drive Contract and adjusts the total amount of said contract to \$560,721.53.
