Please be advised that your request for door-to-door canvassing is approved. This canvassing permit is valid from February 3, 2020 through March 4, 2020


Solicitation is to occur **ONLY** from 10:00 a.m. to 6:00 p.m. Monday-Saturday, and from 12:00 p.m. to 2:00 p.m. on Sundays, per our Township ordinance.

You must carry with you the enclosed Solicitor Permit/Registration Certificate, as well as the Jackson Township No Knock Registry. It is recommended that you wear or display a clear form of Company Identification when going door-to-door.

Regarding our "No Knock" registry, **These residents have indicated they do not wish to be solicited under any circumstances. If a residence is not on the registry but the home displays a No Knock sticker, that resident must not be solicited as well.** Please also bear in mind that soliciting is generally prohibited in our private communities as listed, but not limited to: Winding Ways, Westlake, Four Seasons Metedeconk, Four Seasons South Knolls, Cooks Bridge Condominiums, Crystal Brook, Three Pence Brook, Sixty Acre Reserve, all apartment complexes and other multi-family complexes. I strongly urge you to reach out to those management groups **before soliciting** to ensure if door-to-door canvassing is allowed in those communities. These communities generally display NO SOLICITATION signs, which must be obeyed.

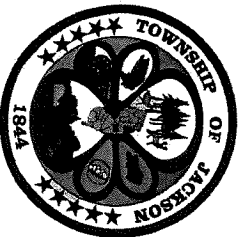
